# Omnibus Alcoholic Beverage Regulation Amendment Act of 2016:

After several meetings with ABRA, as well as testifying on the bill, HAWDC is happy to announce that last week, the District Council held its final vote on the "Omnibus Alcoholic Beverage Regulation Amendment Act of 2016." As we previously informed you, this bill amends Title 25 of the District of Columbia Code to clarify the conflict of interest law to allow a hotel that currently holds an ABC on-premise retail license to also obtain an off-premise retail license. The bill would allow hotels to sell closed containers of beer or wine to its guests from a hotel-run market pantry so long as the store does not have direct public access to the street or the outside of the hotel's building.

Once the bill is signed by the Mayor and passes a 30-day Congressional review period, the new law would allow District hotels to have a dual license to accommodate guests' requests to purchase closed containers of beer or wine to take back to their rooms to consume at their leisure. If interested in obtaining this license, hotels will then have to apply for a new license with the District's Alcoholic Beverage Regulation Administration.

## **Universal Paid Leave Amendment Act of 2016:**

On Tuesday, December  $6^{th}$ , the District Council held its first vote on the "Universal Paid Leave Amendment Act of 2016." As we previously informed you, this bill would establish a government-run fund, supported by a payroll tax on all District private employers, to pay employees for leave to take care of themselves, a child or other family member.

The Council is scheduled to have its second and final vote on the bill on Tuesday, December 20<sup>th</sup>. HAWDC will continue to express our concerns for the bill to Councilmembers and the Mayor. We will keep Members updated as the bill works its way through the legislative process.
