## **District Increases Minimum Wage to \$15 an Hour:**

As you are aware, in April, Mayor Bowser introduced the "Fair Shot Minimum Wage Amendment Act of 2016" to the District of Columbia Council to increase the city's minimum wage. On Tuesday, June 21st, the District Council held its final vote on the legislation and Councilmembers voted unanimously to increase the District's minimum wage to \$15 an hour by the year 2020. The legislation also increases the tipped minimum wage to \$5 an hour by 2020. Both the \$15 and \$5 will be indexed to the Consumer Price Index (CPI) after 2020.
