HAWDC Testifies at Hearing on Short-Term Rental Regulations:

Last week, the District Council held a hearing on the "Short-Term Rental Regulation and Affordable Housing Protection Act of 2017." As you are aware, the bill would require the Department of Consumer and Regulatory Affairs ("DCRA") to inspect short-term rentals for violations of health and safety, establish requirements governing the use of short-term rentals, and require short-term rental hosts to obtain a basic business license. On behalf of HAWDC, Solomon Keene testified in support of the bill and urged the Council to pass reasonable and commonsense regulations that would create an equitable regulatory environment for everyone providing lodging accommodations to travelers to our city.

HAWDC stressed that the District must pass strong legislation that gives DCRA the ability to rid the market of illegal hotels. These commercial property owners are acting as *de facto* hotels, providing accommodations to transient guests without complying with the myriad of regulations that traditional hotels are required to comply with and it is unreasonable to allow these commercial proprietors to operate free of any regulatory structure or oversight. HAWDC will continue to monitor this bill as it works its way through the legislative process and update members accordingly.
