District Agencies to Conduct Presidential Inauguration Inspections of Hotels:



In preparation for the Inauguration in January 2017, the DC Presidential Inaugural Committee has tasked the District Government with inspecting hotels for safety and code compliance.

Beginning this month, the Department of Consumer & Regulatory Affairs (DCRA), Department of Health (DOH), and Fire & Emergency Management Services (FEMS) will be conducting inspections of all District hotels. The inspections will be similar to the routine inspections hotels receive and will focus on:

- Property maintenance in the common areas, ballrooms and guest rooms (DCRA)
- Food sanitation in food service areas and ballrooms (DOH); and
- Life safety ingress/egress in common areas; sprinkler maintenance; and evacuation planning.

Members should advise their staff of the upcoming inspections and that the inspections may be unannounced. For any questions regarding the inspections, please call 202-442-9543 or e-mail
