We Won: D.C. Court of Appeals Affirms Judgment Ordering Online Travel Companies to Remit Unpaid Sales Taxes:



Last week, the D.C. Court of Appeals upheld the District Court's ruling requiring online travel companies Expedia, Hotels.com, Hotwire, Travelscape, Orbitz, Travelocity, and Priceline to pay more than \$60 million in unpaid sales taxes and interest owed to the District of Columbia. The Court affirmed the government's assertion that these companies are liable to pay sales tax on the entire

amount they charge to guests, rather than the amount they pay to hotels for the rooms. The District's Attorney General, Karl A. Racine, stated that this win "ensures that online travel companies have to follow the same rules as everyone else."

"We are thrilled that online travel companies will be required to pay their fair share of taxes in the District of Columbia. This decision not only reinforces our position that these taxes are owed to the District but hopefully sends a message to OTCs that the days of misleading consumers are over," said Solomon Keene, President, HAWDC. As you are aware, HAWDC has long held the assertion that these taxes were due to the District, and brought this issue to the attention of the District government. Through HAWDC's efforts, the District Council passed the "Payment of Full Hotel Taxes by Online Vendors Clarification Act of 2010," which clarifies that these online travel companies are required to collect the entirety of the tax collected on the purchase of the rooms. This law was the impetus for the lawsuit that was filed.

HAWDC would like to thank Mayor Bowser, the District Council, and the Attorney General and his team, for ensuring that these companies collect and remit the taxes that are due to the District. This decision is a huge win for the District of Columbia and our industry!
