

## ABRA First-Quarter Statements and Books and Records Training:

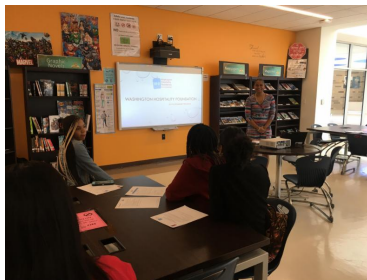
This is a reminder that all hotels and restaurants that have an ABC license are required to file their first-quarter statements with the District's Alcoholic Beverage Regulation Administration (ABRA) by **Tuesday, April 30, 2019**.

First-quarter statements are required to report sales and expenses for food and alcohol from January through March. [Complete details and forms are available on ABRA's website.](#)
